COVID-19 Virus Update Information

The impacts of COVID-19 Virus are being felt throughout our community and around the world. Federal and provincial governments are working on measures to help address the financial challenges resulting from this epidemic. While we await the full realization of these measures, we remain focused on keeping our tenants safe and housed. Your health, safety and well-being is a top priority.

Some measures that already have been implemented:

- **Closed** all on-site offices and recreation rooms to the public until April 6, 2020
- **Suspended** non-emergency entry to units by staff
- **Cleaning**– we have implemented cleaning and disinfection procedures recommended by Public Health

Rent payments: those residents who pay their rent by PAP (pre-authorized payments) must report any requests related to payments about 5 business days before the 1st day of the month. Those residents who usually pay rent by Interact/debit card will be required to submit rent by money order, certified cheque or on-line/telephone banking payment on or before 1st day of the month.

If you are unable to pay your rent in full or on time due to the change in income as the result of the COVID-19 implications, please contact the management office. We would be happy to work with you to make alternative arrangements.

HOW YOU CAN HELP

To help keep you and your neighbours safe, and to help us serve you during this extraordinary time, we ask you that you comply with the following:

DO NOT

- **congregate in common area**

- gather in groups of more than 2 people
- touch your face
- flush paper towels, sanitary wipes, or feminine hygiene products down the toilet

DO

- limit non-essential visitors or guests
- continue to report all maintenance issues in your unit, even non-emergency
- wash your hands several times a day for 20-30 seconds
- maintain a 2-meter distance from others
- self-isolate if you have returned from abroad in the past two weeks (inform the office)
- stock up (to ensure you have enough, do not hoard) on essentials like prescription medication and food items
- report to your health care provider and/or public health if you are experiencing any of the following symptoms: cough, fever, or difficult breathing
- make arrangements with friends or family for assistance with essential tasks
